
Our training course and RE Conferences continue to be well supported and appreciated by teachers from the County and the City along with teachers from Derbyshire this year.

1. What is SACRE?

The 1988 Education Reform Act established the statutory requirement for all local authorities (LAs) to establish a permanent body called a Standing Advisory Council for Religious Education (SACRE). The Nottinghamshire SACRE is an independent body which advises the LA on matters concerned with the provision of Religious Education and Collective Worship.

SACRE comprises four groups:

Group A: Elected County Council

Representatives

Group B: Church of England

Representatives

Group C: Teacher Representatives

Group D: Representatives of Christian

denominations and other religions reflecting the

principal religious traditions of

the area

Each group has equal status and voting rights.

Functions of SACRE

Executive functions:

- To consider and determine (in accordance with Section 12 of the 1988 Education Act) applications from county schools to be disapplied from the requirements concerning Collective Worship being broadly Christian.
- To consider whether or not to require a review of the Agreed Syllabus adopted by the Cabinet.

• To publish an annual report.

Advisory functions:

- To give advice on methods of teaching the Agreed Syllabus for Religious Education.
- To advise the LA on the provision of training for teachers.
- To monitor inspection reports and standards of achievement in Religious Education.
- To give advice on Collective Worship.


Purpose

Within its statutory responsibilities SACRE is concerned to support and enhance the provision of Religious Education within Nottinghamshire schools where the Agreed Syllabus is in use. SACRE seeks to encourage the provision of high-quality in-service training for those whose responsibility it is to deliver this aspect of the basic curriculum.

Decision making

This is determined by one block vote from each of the four groups listed in the membership above.

Co-opted members do not vote.



2. Meetings

There were three meetings of SACRE in the academic year 2009-2010.

Main issues discussed at the meetings:

November 2009

- We accepted the SACRE Effectiveness Plan for 2009-2010 and several issues were highlighted for follow up
- Report received on the largest RE Conference to date, when the Agreed Syllabus had been launched. Members watched a video of the keynote speech at the conference
- The Nottinghamshire Draft SACRE Annual Report was presented.
- National Developments in RE were reported to SACRE

February 2010

- The meeting was held in the Guru Nanak Sat Sang Gurdwara in Nottingham, where members toured the Gurdwara
- Review of the Co-option of the BHA representation was discussed.
- Date of the RE Conference had been changed to avoid a clash of events in the summer.
- Discussion of issues raised from the Effectiveness plan
- Draft Annual Report was discussed
- Religious Education in English Schools: Non-statutory guidance 2010 was distributed for information

June 2009

- Met at St Peter's CE Primary School, East Bridgford
- SACRE members had a tour and talk about RE in the School and saw evidence of work by students
- New members were welcomed to SACRE
- Details of the RE Conference at the Racecourse were given and how we were attracting schools from Derbyshire.
- Primary RE training on the Agreed Syllabus had been so popular that a repeat was being planned for October
- Discussion of Non-statutory
 Guidance for RE document. In
 particular there was discussion
 about Role of LA and SACRE;
 academies and the relationship
 with higher education
 establishments
- National Celebration of RE for March 2011 was mentioned
- Training CD from NASACRE was circulated for members to see.
- Report on SACRE & INTERFAITH was issued
- County Policy on Collective Worship - following an enquiry, SACRE decided to adopt the guidance given in the National Guidelines 1/94 on worship which were still in force.



3. Determinations

From time to time a school may request from the SACRE a "determination", that is, permission to waive the legal requirements for religious education and collective worship to be 'wholly or mainly Christian'.

There were no requests by schools in Nottinghamshire for a determination that the specific requirements regarding the character of collective worship, as set out in the Education Act 1996, should not apply to them.

4. Professional development opportunities

Course offered for 2009-2010:

In support of the implementation of the Agreed Syllabus from September 2010 the following courses were offered. These were offered to teachers cross the City and the County as part of a collaborative package of support

Primary Focussed Days
 Three days in the autumn term but due to demand we organised a further repeat day in the summer term. The support for this meant that we planned another day in October 2010

98 teachers supported these dates

- Secondary Focussed Day
 One Day in the autumn term
- Spring Term 2010
 We offered opportunities for teachers to meet for twilight

sessions in order to become familiar with the New Agreed RE Syllabus. There was sufficient support to run three of these sessions in different venues across the City & County

SACRE RE Conference

We offered a Conference for teachers of RE across all key stages in the summer term at the Nottingham Racecourse.


What a fantastic day at our first racecourse RE Conference as the participants, all arrived in good time for the 9.30 start. We welcomed colleagues from Derbyshire Schools as well as from the City and the County.

The Conference also had exhibitors present from the City and County who work to enhance RE.

There was a display from Stapleford Centre and TTS, along with a display from the holocaust centre at Beth Shalom. The RSResource Centre was present along with Time Travelling from Southwell Minister and the William Booth Birthplace Museum – Nottingham. We also welcomed Muslim resources from Leicester.

6. Standards in RE in Nottinghamshire

As the nature of Ofsted inspection reports has altered it has become difficult to comment upon their findings with regard to RE and Collective Worship.

Examination performances

Entry level Certificate in Religious Studies offers candidates not yet ready for the GCSE the opportunity to focus on religious and moral issues, which relate to their own lives, and to meet the statutory requirements for Religious Studies. This was the first year we have entries for this examination.

120 students were entered 45.8 % achieved Level 3 40% achieved Level 2 13.3% achieved Level 1

GCSE Full Course

SACRE noted that there was a another decrease in candidates this year, as 1654 pupils sat the full GCSE course compared to 1855 in the previous year. Nationally there was an increase in the numbers sitting at this level.

OCR continues to be the most popular examination board across the County's schools followed by Edexcel.

GCSE Short Course

Our entries for the short course decreased from 4424 entries in the previous year to 3795 last year in the County's schools.

SACRE is pleased to note that these results indicate that there have been some signs of improvement within the County schools but this is an area to support so we can reflect the National trends more.

Considering these results, SACRE needs to continue to consider how schools can be supported in order to raise achievement further and to consider ways in which schools can promote examination work in Religious Education.



7. Areas for further improvement

Targets for further improvement:

- Continue to improve the levels of achievement across all key stages, particularly Key Stage 4 and 5.
- 2. Liaison with Higher Education Institutions to consider ways of enhancing the examination performances of students in County Schools.
- Develop the awareness of SACRE of the needs of teachers to achieve increasing examination numbers and levels
- 4. Create greater awareness of the work of SACRE.

Support for schools in bringing about further improvement

- 1. To promote and monitor effective training to support schools in improving the quality of RE and raising standards through courses and the RE Conferences.
- 2. Give clear guidance and support for schools in developing more effective assessment strategies through training and the use of new guidance materials being produced by the QCDA.
- 3. Developing access to and

promotion of Resources at the Bluecoat RS Resource Centre.

4. Offering guidance on developments in RE teaching and learning.
